Application Information

Preparation

When you are experiencing an ant infestation NOPE!® CP Ant Killer is an important part of a control strategy. To ensure a successful treatment the following steps should be followed in preparation for the application to NOPE!® CP Ant Killer.

- If possible identify the ants the most common species are the Black Garden Ant (Lasius niger), the Argentine Ant (Linepithema Humile) and Pharaoh Ants (Monomorium Pharaonis).[1]
- · Identify the paths the ants use through the house and where they may be entering the house.

In addition to using NOPE!® CP Ant Killer the following steps are recommended:

- · Remove sources of food for the ants e.g. ensure sticky sugary residues are wiped up, crumbs are cleaned up and foods are kept in sealed containers.
- · Carry out DIY to block entry points into the house.
- Use bait stations such as Nope!® Ant Killer Bait Station.[2]

^[1] It is not advisable to use spray approaches on Pharaoh Ants as this can cause the colony to splinter and form new nests. It is recommended that bait stations are used to control Pharaoh Ant infestations.

Care should be taken when using bait stations and sprays ant killers in combinations. Bait stations rely on the ants living long enough to carry the poison back to the nest. Using spray products like Nope! CP Ant Killer may prevent the ants from returning to the nest.

Application

Read the label before treatment. **NOPE!**® **CP Ant Killer** should be sprayed onto the paths followed by ants, preferably around locations where they enter the home. Using the spray bottle provided at a rate of 25 – 50 ml per metre square. A 500 ml pack should cover 10 to 20 m².

Wash hands thoroughly after use. Keep unprotected people and animals away from treated surfaces until they are fully dry.

NOPE!® CP Ant Killer is not to be used on food contact surfaces.
