## Product Description

**NOPE!® CP Bed Bug Killer** is formulated to kill bed bugs quickly, leaving long-lasting residue to provide ongoing protection. It is designed for use as part of a bed bug infestation control strategy.

**NOPE!® CP Bed Bug Killer** can be applied directly to carpets, floors, soft furnishings, bed frames, and other areas of activity. It is not to be used on human bedding – instead all bed linen should be thoroughly cleaned using an extended wash cycle at the highest temperature compatible with the material (minimum 60 °C).

## Application Information

### Preparation

When you are experiencing a bed bug infestation **NOPE!® CP Bed Bug Killer** is an important part of a control strategy. To ensure a successful treatment the following steps should be followed in preparation for the application to **NOPE!® CP Bed Bug Killer**.

- Bed bugs are nocturnal, so look for them at night and try to establish the extent of the infestation.
- Bed bugs are hard to eradicate due to their ability to hide in tiny cracks and crevices. So the full area that requires treatment is likely to extend beyond the bed.
- Develop a methodical strategy of treatment. You want to ensure that the infestation is not driven into previously unaffected areas.
- Consider carrying out multiple treatments to get the infestation under control.

In addition to using **NOPE!® CP Bed Bug Killer** the following steps are recommended:

- Strip the bedding off the bed and carry out a hot wash (minimum 60°C).
- Vacuum the area to be treated – this will remove the adults, but not the eggs. Immediately empty the vacuum and dispose of the contents into a sturdy bin bag. This will contain adult bed bugs so it should be put outside straight away to prevent reinfestation.

Remove any pets from the area, only allowing them back when the treated areas have had time to dry and have been fully ventilated. Leave the treatment to dry for a minimum of 3 hours, but preferably overnight, and ensure good ventilation before reintroducing pets.

Apply a small amount of **NOPE!® CP Bed Bug Killer** to an inconspicuous test area of each substrate to be treated (e.g. carpet, sofa) before full treatment commences to ensure compatibility with the substrate.

## Application

Read the label before treatment.

**NOPE!® CP Bed Bug Killer** should be sprayed onto hard surfaces and soft furnishings. Areas to consider treating are

- **Beds** – In some cases, partial dismantling may be necessary to allow **NOPE!® CP Bed Bug Killer** to be applied to all areas where bed bugs can hide.
- **Mattresses** – pay particular attention to buttons, folds and seams where bed bugs may hide.
- **Walls** – pay particular attention to cracks, which can commonly be found around skirting boards, plug sockets and light switches. Damaged and peeling wallpaper should also be sprayed.
- **Floors** – gaps between floorboards, within and around carpets (also pull back carpets at the edges to allow application of **NOPE!® CP Bed Bug Killer** underneath the carpet).
- **Furniture** – all furniture should be thoroughly treated, ensuring all sides are treated and paying particular attention to cracks and crevices.
- **Door and window fittings** – around door frames and window frames and handles.

Using the spray bottle provided at a rate of 25 – 50 ml per metre square. A 500 ml pack should cover 10 – 20 m<sup>2</sup>.

Wash hands thoroughly after use. Keep unprotected people and animals away from treated surfaces until they are fully dry.

After treatment, avoid vacuuming the room for as long as possible – preferably for a minimum of 14 days. This helps to prolong the residual effect of the **NOPE!® CP Bed Bug Killer** treatment, ensuring that as large a proportion as possible of the bed bug population come into contact with treated surfaces.

**NOPE!® CP Bed Bug Killer** is not to be used on human bedding, pet bedding, pet sleeping quarters, or where pets frequently lie – instead these areas should be thoroughly washed with hot water.

**NOPE!® CP Bed Bug Killer** is not to be used on food contact surfaces.
