Application Information

Preparation (floors, carpets, and soft furnishings)

Apply a small amount of NOPE!® CP Flea Killer to an inconspicuous test area of each substrate to be treated (e.g. carpet, sofa) before full treatment commences to ensure compatibility with the substrate.

Before treatment, clear as much floor space as you can to ensure that treatment is as thorough as possible.

Vacuum all areas prior to treatment. This has three advantages:

- · Helps to remove any debris, eggs, larvae, pupae and adult fleas
- The vibration of the vacuum cleaner stimulates adults to hatch from their cocoon stage. NOPE!® CP Flea Killer is most effective against adult fleas.
- Enables NOPE!® CP Flea Killer to penetrate down to the base of the carpet fibres where fleas live.

After using your vacuum cleaner always empty the contents into a black plastic bag. This will contain eggs, larvae and adult fleas and it is important to prevent any of these reinfesting the home. Therefore, immediately seal the bag and dispose of it in an outside bin.

Store away exposed foodstuffs and make sure you fully cover and seal any fish tanks.

Remove any pets from the area, only allowing them back when the treated areas have had time to dry and have been fully ventilated. Leave the treatment to dry for a minimum of 3 hours, but preferably overnight, and ensure good ventilation before reintroducing pets.

Application

Read the label before treatment

NOPE![®] **CP Flea Killer** should be used on hard and soft furnishing, carpets, floors, curtains, crack and crevices and other areas of activity. Apply the product using the spray bottle provided at a rate of 25 - 50 ml per metre square. A 500 ml pack should cover 10 to 20 m².

Wash hands thoroughly after use. Keep unprotected people and animals away from treated surfaces until they are fully dry.

NOPE![®] **CP Flea Killer** is not to be used on human bedding, pet bedding, pet sleeping quarters, or where pets frequently lie – instead these areas should be thoroughly washed with hot water.

NOPE![®] **CP Flea Killer** should not be applied to pet's fur or skin. Veterinary approved flea treatments should be used for this purpose.

- Application of veterinary approved flea products to your pet on a regular basis
- Brush out your pet's fur before going inside after walks, etc.
- Frequent vacuuming of the affected home, paying particular attention to the areas frequented by pets especially carpeted areas, furniture that is used by pets, pet sleeping areas, etc.
- Regular washing of pet's bedding, blankets and other washable items in the hottest water possible.
